36-5-2-4.1. Town legislative body and executive:

(a) The Board hereby divides the Town into districts for the purpose of conducting Town elections.

(1) Ward One: being all that territory commencing on the North bank of White River where it intersects the East line of Madison Avenue, and running thence North on the East line of Madison Avenue to the centerline of North Shore Boulevard; thence Northeasterly along the center line of North Shore Boulevard to

the Southwest corner of Lot 7 in Country Club Estates Addition; thence Northwesterly along the West line of said Lot numbered 7 and the centerline of Overlook Drive to the Northwest corner of Lot 8 in said Addition; thence East along the North line of Lots 8, 9 and 10 to the East line of the West half of the West half of Section 1, Township 19 North, Range 7 East; thence North along said line to the North Corporation line; thence East along said line to the West right of way line of the Conrail (formerly C.C.C. & St. Louis) Railway; thence Southwesterly along said line to the North bank of White River; thence Southwesterly on the North side of White River to the place of beginning.

(2) Ward Two: being all that territory commencing at the Southwest corner of Lot 1 in Country Club Addition, and running thence East to the East line of the West half of the West half of Section 1, Township 19 North, Range 7 East; thence South along said line to a point where the same intersects the North line of Lot 10 in Country Club Estates Addition; extended to the East; thence West along the North side of Lots 10, 9, and 8 in said Addition to the centerline of Overlook Drive, thence South along the centerline of Overlook Drive and the West line of Lot 7 in said Addition to the centerline of North Shore Drive; thence Westerly along said line to the East line of Madison Avenue; thence North along the East line of Madison Avenue to the place of beginning.

(3) Ward Three: being all that territory beginning at the Southwest corner of Lot 1 in Country Club Addition, and

running thence North on the East line of Madison Avenue to a point 691 feet North of the Northwest corner of the Southwest Quarter of the said Section 1, Township 19 North, Range 7 East; thence East to the East line of the West half of the West half of said Section; thence South to a point due East of the point of beginning; thence West to the point of beginning.

(b) If any part of the Town has not been described as included in one of the wards described in this section it shall be deemed included within that ward which is contiguous to that part and contains the least population of all wards contiguous to that part according to the 1980 decennial census.

(c) If any part of the Town has been described in this section as being included in two (2) or more wards, it shall be deemed included in that ward which is one of the wards in which that part is described in this section, is contiguous to that part, and contains the least population of those wards according to the 1980 decennial census.

(d) Subsection (a) shall be deemed repealed, effective December 31, 1992. The Board shall redistrict the Town prior to that date, as required by I.C. 36-5-2-4.1, as amended.
